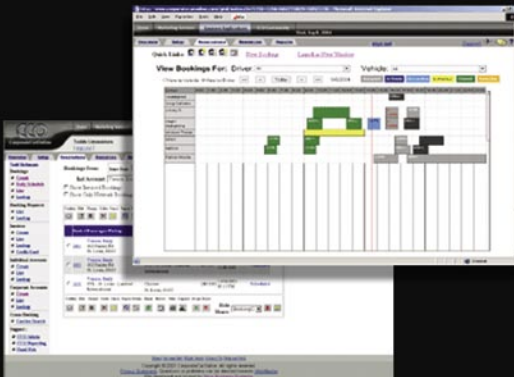

Airports - Most corporate transportation involves airport service to and from Palm Beach, Fort Lauderdale, and Miami International Airports. We provide service to smaller commuter and executive airports in the tri-county area as well. Most corporate clients, executives and employees commonly travel in sedans, SUVs, and stretch limousines. Transportation for passengers of six or more with luggage will often require our transport van, or mid size bus.

Airport Inside Meet & Greets - You may choose from a variety of ways to have you or your client meet the driver upon arrival from a flight. If you or your client are NOT familiar with an airport FCS strongly suggests having a driver go inside to greet you. A fee of \$15.00 dollars is applied to US Customs Meet and Greets for international flights at any airport. For arrival of domestic flights, you can choose to be met at security or at baggage with you or your clients name on a sign. Domestic flight meet and greets are FREE. You just need to pay for the parking of the vehicle.



Airport Curbside Pick Ups - Other options are to have a driver wait just outside the airport for a curbside pick up. You or your client may call FCS to say when and where you'll be walking out. We will then notify the driver to go to the pick up location. You may choose to have the driver call your mobile number the moment the plane is at the gate. You may then coordinate where and when the driver will pick you up. The driver will leave a voice message with a number to call back if the driver cannot reach you. This option is best used for people who are familiar with that airport.

Other additional fees are as follows: (extra stops, parking, tolls, and wait time) You have 15 FREE minutes of wait time on every transfer. Ice & Beverages in Limousines are not included in any transfer service, however you may request it for a small fee of \$15.00. Child Car Seats are available for FREE at your request. Most Corporate transfers are serviced in Sedans & SUVs. The garment trailer must be used if you are at max vehicle occupancy in an SUV, van or bus with lots of luggage. The chart to the right provides a guide for seating with luggage in our vehicles. Luggage amounts are approximated.
